<p>Toward a Holistic Model for the Management of Documents, Records, and Archives with Digital Transition at the Information Age</p> <p>Abstract</p>		
<p>This speech is based on the Director-General's strategic concern, and incorporated the key concept from her doctoral dissertation which aims to find a more applicable model to manage the whole life of all records in all media in the information age. It is included the tendencies of archival theories and practices, and a new model named "Interactive and Integrated Model for the Management of Documents, Records, and Archives (I² DRA)". I² DRA merges the advantages of the Life-Cycle and Records Continuum models, bridges their gaps, and highlights information openness, information governance architecture, long-term preservation, risk management, and other critical characteristics. Some digital transition policies are also proposed, which intend to change the process, to progress the effectiveness, and to innovate the public services.</p>
